Ref No.:- 2-1/2021-BERH/NCH/1408 dated 16.05.2023 and even letter No.2-5/2021-BERH/NCH/14/2489 Dated 08.06.2023 (BERH-National Commission for Homoeopathy (GoI), New Delhi).

With reference to above cited vide letters No.'s of the National Commission for Homoeopathy (NCH) (Preparation and Maintenance of National Register for Practitioners of Homoeopathy) Regulations 2022 sub-Regulations (1), (2), (3) and (4). The Board of Ethics and Registration for Homoeopathy shall be maintained the National Register for Homoeopathy (NRH) in the form as specified in the Regulation, both in electronic and physical format. The National Register shall be prepared on the basis of list of Registered Medical Practitioners as provided by the State Medical Council/Board for Homoeopathy. As such all the Medical Homoeopathic Practitioners are directed/advised to fill up all column of the registration application form showing (1) Aadhar Number (2) Phones, Fax and Mobile with email Id address (All the means of contacts available) (3) HPR (ABDM) ID Number (4) Name of Hospital or institute with complete address for purpose of teaching or research or practice of medicine. (If the candidate working in the same institution then the name and address of the institution shall be written and if candidate is self-employed the name of concerned practitioners and address of the clinic shall be mentioned) in the registration form and same to be submit to the office of J&K Board of Homoeopathic System of Medicine through online portal link www.bhsmjk.org, taken as most important before cut off date i.e. 15.03.2024, so that requisite informations as required/desired by the Board of Ethics and Registration for Homoeopathy (BERH) of National commission for Homoeopathy (NCH) Government of India, New Delhi be submitted timely to update their National Register of Homoeopathy (NRH). The Registration data of the Homoeopathic practitioners of Union Territory of J&K already supplied to the Board of Ethics and Registration for Homoeopathy (BERH) of National Commission for Homoeopathy (GoI), New Delhi but the same has not been entertained by the National Commission for Homoeopathy (GoI) New Delhi as the information provided by the Board is not upto the form specified in the regulation. As such all the registered practitioners of Homoeopathy of J&K are advised to provide the requisite informations before scheduled date as cited above mentioned subject, so that the current data of the practitioners as desired by the NCH shall be submitted to the concerned quarter for action at their level.

It is advised to all the registered practitioners of J&K may kindly supply the information before the date of mentioned in this notice. Please note if the requisite information is not supplied by any registered practitioners before cut off the date shall be treated as non compliance by the practitioners of the Homoeopathy, if any.

Maintenance of National Register for Homocopathic Practitioners Regarding: -

Madam/Sir.

With reference to the subject cited above, National Commission for Homoeopathy (Manner of Preparation and Maintenance of National Register for Practitioner of Homoeopathy) Regulations, 2022.Sub Regulation (1) (2) (3) and (4) of Regulation 3, The Board of Ethics and Registration for Homocopathy shall maintain the National Register for Homoeopathy in the Forms as specified in the Regulation, both in electronic and physical formats. The National Register shall be prepared on the basis of list of registered medical practitioners as provided by the State Medical Councils for Homoeopathy. Every State Medical Council for Homocopathy shall also maintain and regularly update the State Register in the Form-1 and Form-2, both in the electronic and physical formats and also supply physically signed two copies of the same to the President of the Board of Ethics and Registration for Homoeopathy on quarterly basis as per the time schedule mentioned in the following table, namely: -

(1)	Tree 01st Innuary to 31st March	upto the 15th April
1.	Data of Pagistered Practitioner From 01st April to 30. June	upto the 15th July
2.	Deta of Registered Practitioner From 01st July to 30 September	upto the 15th October
3.	Data of Registered Practitioner From 01stOctober to 31st	upto the 15th January
4.	December	

Administration concerned shall ensure that licenses or registrations granted prior to constitution of the Commission are to be updated in Form - 1 and Form - 2, in a time bound manner but within a maximum time- period of one year from the date of commencement of these regulations (i.e., Before December 14 0f 2023).

In view of above, All the State Councils are instructed to update the State council Register for maintenance of National Register in a time bound manner.
