Madam/Sir,

With reference to subject cites above, I am directed to inform you that, National Commission for Homoeopathy (Manner of Preparation and Maintenance of National Register for Practitioner of Homoeopathy) Regulation, 2022. Sub regulation (1)(2)&(3) regulation 3 is as under:-

**"Maintenance of National Register.** – (1) The Board of Ethics and Registration for Homoeopathy shall maintain the National Register for Homoeopathy in the Forms as specified in the National Commission for Homoeopathy (Submission of List of Homoeopathy Practitioners) Rules, 2021, both in electronic and physical formats.


(2) The National Register shall be prepared on the basis of list of registered medical practitioners as provided by the State Medical Councils for Homoeopathy and the data of direct registration made by the Board of Ethics and Registration for Homoeopathy.

(3) Every State Medical Council for Homoeopathy shall also maintain and regularly update the State Register in the Form-1 and Form-2, both in the electronic and physical formats and also supply physically signed two copies of the same to the President of the Board of Ethics and Registration for Homoeopathy on quarterly basis as per the time schedule mentioned in the following table, namely:-

| Serial Number | Details of Data  | Time-Period                       |
|---------------|--|-----------------------------------|
| (1)           | (2)  | (3)                               |
| 1.            | Data of Registered Practitioner From 01 <sup>st</sup> January to 31 <sup>st</sup> March    | upto the 15 <sup>th</sup> April   |
| 2.            | Data of Registered Practitioner From 01 <sup>st</sup> April to 30 <sup>th</sup> June       | upto the 15 <sup>th</sup> July    |
| 3.            | Data of Registered Practitioner From 01 <sup>st</sup> July to 30 <sup>th</sup> September   | upto the 15 <sup>th</sup> October |
| 4.            | Data of Registered Practitioner From 01 <sup>st</sup> October to 31 <sup>st</sup> December | upto the 15 <sup>th</sup> January |

In a view of above, all the State Councils/Boards are requested to send the Data of **New Practitioners** of Homoeopathy with all details as prescribed in Form-A regularly as per the above schedule on urgent basis, as well as to update the data of existing practitioners at the earliest.

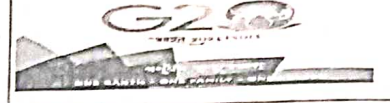
